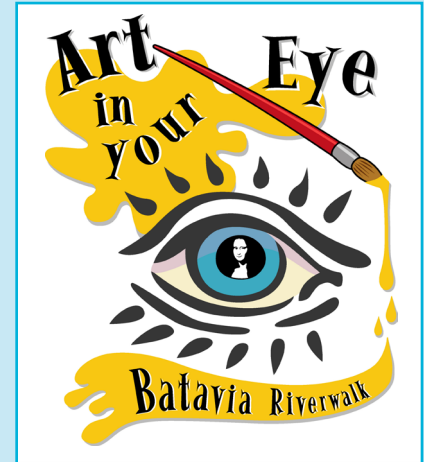

## Selections and Awards Juror

This year's juror/judge, George Turner, is a 1967 MFA graduate from the University of Chicago and studied painting and drawing at the Akademie der Bildenden Künste in Nürnberg, Germany. His work has been exhibited throughout the country and his paintings are in many corporate and private collections.

## Awards

Our juror will select award winners. A total of \$650 in cash and prizes will be awarded. Awards will be announced at 11 a.m. on Saturday, August 14, at the exhibit.

## About the Exhibition

The juried Batavia City Hall Art Exhibit is a part of the Art in your Eye Festival at the beautiful downtown Batavia Riverwalk. The exhibit will be held in the Council Chambers, just steps away from the outdoor Fine Art Show and other festival activities.

## Eligibility and Restrictions

Participation is open to any artist residing in Illinois and surrounding states, 18 years of age or older, working in any fine art media including, but not restricted to, drawing, painting, printmaking, pottery, photography, sculpture.

Each artist may submit up to three works for consideration. Works must have been executed in the last 3 years. Works must be original. Photo-reproductions or prints of original works are not eligible. Work that has been produced with commercial kits, molds, plans, forms, or other commercial methods is not permitted. Artwork must be new to the City Hall Exhibit.

To comply with the size of our display system, framed work may not exceed 36 inches horizontally or 36 inches vertically - NO EXCEPTIONS. Art must be framed for hanging using screw eyes and hanging wire. No sawtooth hangers will be accepted. Free-standing 3-D work cannot exceed 3' x 3' x 8.'

## Image Preparation

Jurying will be done from Jpegs submitted on a CD. Submit up to three works of art. Images must be high-resolution and not enhanced. Crop the image to the frame or outer edge of the artwork. Clearly label your CD with your name and phone number. Name each image with your last name and one or two word descriptor, and your entry number. Example: smith-mountains-1.jpg. Make sure you include title of work(s), media, and size on the application form. CDs may be picked up at art drop off.

## Sales

A sale price or NFS may be marked on each piece. Sales can be made during the Exhibit. Pieces will be marked SOLD, but need to remain on display until the end of the exhibit on Sunday, August 15. No commission is taken.

## Delivery and Pick Up

Accepted artworks must be hand-delivered to the Council Chambers located at 100 N. Island Ave., Batavia, IL, on Friday, August 13, 2010, from 10 a.m. to 4 p.m.

Following the close of the exhibit on Sunday, August 15, unsold artwork must be picked up between 4 and 6 p.m.
